TAKATA CRISIS : VITAL EMERGENCY IN GUADELOUPE





In the context of the life-threatening risks posed by TAKATA airbags, we wish to clarify that certain vehicles imported into Guadeloupe, and more generally into the French Overseas Departments (DROM), through brokers or as part of personal relocations, may not be immediately identified in the ongoing Takata recall campaigns.

Since 2022, GSA has been actively committed to securing vehicles affected by the Takata airbag recalls, making every effort to inform and support its customers. We emphasize that it is crucial for owners of vehicles imported through parallel channels to report their situation to GSA in order to be registered and identified as part of the Takata recall campaigns.

We encourage anyone with questions regarding their vehicle to check its compliance by following the procedure described below. We reaffirm that addressing the Takata recall campaigns is our top priority in order to protect our customers as effectively as possible and to prevent any future risks. This is truly a race against time, as vehicle wear and aging significantly increase the risk of fatal accidents. We therefore urge all drivers of affected vehicles to visit the workshop for free to secure their vehicles.

About the Takata Recall Action:

The global recall campaign for defective airbags from supplier TAKATA involves numerous automakers, including Volkswagen models. Takata supplied the automotive industry with defective airbags or those containing faulty gas inflators. If your vehicle is equipped with these airbags, it is possible that over time and under certain climatic conditions (heat and humidity), they could become dangerous and require replacement or repair. Indeed, they may increase the risk of serious or even fatal injuries for you and your passengers in the event of an accident. GSA
